<u>DESCRIPTION OF WORK:</u> This RFP is being issued to retain the services of an attorney or a law firm to represent the District in those instances, and in other legal matters as may be needed from time to time. These services may include, but are not limited to:

- Advise the District regarding agreements, contracts, and public relations.
- Advise the District regarding real estate law, property acquisition, or easements.
- Advise the District on compliance with employment law and human resource matters.
- Advise the District on compliance with applicable federal and Utah state laws, rules, policies, and procedures affecting its operation.
- Provide the District with advice, review, preparation, and drafting services related to its operations, rules, policies, and procedures.
- Advise the District on contracts, and developer and/or contractor relations.
- Advise the District on Government Records Access Management Act (GRAMA).
- Attend meetings at the request of the District's Manager or his/her designee.

SELECTION PROCESS: Submitted proposals will be evaluated and scored by a three-member Evaluation Committee consisting of the District General Manager, Assistant General Manager, and Controller. The General Manager will assign an individual who is not a member of the Evaluation Committee to calculate scores for cost, and add the scores calculated for cost to the Evaluation Committee's final recommended scores on the other criteria to derive the total combined score. The District intends to meet with or otherwise contact the top 3 firms based upon the evaluation criteria listed in the RFP. The interview process will take place if needed during the first part of the month of March 2024, with selection no later than March 25, 2024.
